### Purchaser agrees as follows:

- The breeder prefers, except in cases of extreme necessity, that the above-mentioned cat/kitten not be declawed.
- Under no circumstances will this cat/kitten be sold, leased or given away to any pet shop, research laboratory, shelter of any kind or similar facility. This kitten is being entrusted to you a **forever home**.
- This cat/kitten was purchased as pet quality
- If purchased as a pet the buyer agrees to neuter/spay this cat/kitten between the age of eight (8) and ten (10) months of age.
- If this cat/kitten is found to be neglected, abused or otherwise mistreated, purchaser will surrender said cat/kitten to the breeder unconditionally. The buyer will not be subject to refund or replacement
- Breeder agrees to provide litter registration papers on said cat/kitten with Section E appropriately marked regarding the breeding agreement of this contract and pedigree only after receipt of veterinarian certificate stating the cat has been altered.

- Health Guarantee:** This kitten/cat is guaranteed of sound health upon delivery or arrival, and for a period of 72 hours thereafter if vetted within that time. Failure to have animal checked by a licensed veterinarian within 72 hours will void any guarantee. It is recommended that the new kitten/cat be quarantined during that 72-hour period. If found to be medically deficient with an untreatable or life-threatening problem, this must be reported to the Seller immediately. Upon its return, it will be replaced with another kitten/cat of equal value. The Seller reserves the right to reserve a cash refund. If no replacement is available at the time of return, Seller will have up to one year to furnish a comparable kitten/cat. The kitten/cat can not be returned for compensation after the guaranteed period has expired and/or it has been exposed to another cat. Seller will not honor any health guarantee if the kitten/cat dies of a virus from contact with another animal not bred at this Cattery. The buyer agrees to provide immediate veterinary care to this kitten/cat if it shows signs of distress, illness, or injury. Failure to do so will render the guarantee null and void. Under no circumstances is the kitten/cat to be destroyed prior to notification by the Buyer to the Seller. If the kitten/cat dies within the guarantee period, despite medical treatment, compensation will be made ONLY if a licensed veterinarian certifies the cause of death. It is the Seller's right to ask for the kitten/cat to be returned for identification before providing a replacement or any compensation. Seller will not be responsible for any veterinary bills of this kitten/cat after leaving Seller's residence. It is further agreed by both Buyer and Seller that this guarantee of health is void if the buyer has the kitten vaccinated for FeLV or FIP in the first year of his/her life.
- Buyer guarantees that the cat/kitten is free of any genetic defects for a period of one year from the above sale date.
- New kittens may show signs of stress including, but not limited to sneezing, discharge from the nose and eyes, diarrhea and/or constipation. These effects can be minimized by feeding identical food as served by the breeder, offering bottled or distilled water and overall taking measures to reduce stress during integration period.

If purchaser is found to be in violation of any of these terms and conditions set forth in this agreement the breeder retains the option to sue the buyer for breach of contract and demand the immediate return of cat/kitten to the breeder. Purchaser will assume all costs incurred by the seller in obtaining the cat/kitten. These costs will include, but are not limited to veterinarian costs, attorney fees, travel expenses and cost fees.

If any dispute shall arise between the parties to this contract over any terms contained herein, or in any way connected to this transaction, jurisdiction, venue and choice of law shall lie in the courts of New Jersey.
